

**MINUTES**  
**June 29, 2021**  
**Jackson, Mississippi**

The Mississippi Board of Licensure for Professional Engineers & Surveyors held a meeting on June 29, 2021, using the web conference service known as Zoom. Zoom was used instead of an in person meeting due to health and safety concerns related to the COVID-19 pandemic. The Board's office in Jackson, Mississippi was open and available for public participation; however, there were no visitors on the date and time of the meeting.

**I ROLL CALL AND APPROVAL OF MINUTES**

**1. Roll Call**

On a motion from Board Member Joe Lauderdale and second by Board Member Mike Thornton, the June 29, 2021, the June 29, 2021, meeting agenda was amended as follows and submitted for approval.

Motion carried unanimously.

## **2. Review and Approval of Minutes**

The Board reviewed the minutes of the April 7, 2021, meeting. On a motion from Board Member Joe Lauderdale and second by Board Member Patrick Martino, the minutes were submitted for approval. The motion carried unanimously.

## **II BUSINESS**

### **A. Executive Director's Report**

1. The Executive Director presented information relative to the review and update of the forms, applications and associated instructions required to apply for professional engineering and professional surveying licensure in the State of Mississippi as well as changes to applicable forms considering Mississippi's new universal licensure law.
2. The Executive Director reported that all grant funds had been released and accounted for except for a small unclaimed amount; and if the Board is interested in continuing the program in FY 2023 then he requested the authority to plan for it in the 2023 budget. On a motion by Board member Carey Hardin and a second by Board member Dennis Truax, the Board voted to allow staff to award grants up to \$500,000 in 2023. Motion carried unanimously.
3. The Executive Director presented the financial report dated March 31, 2021, and May 3, 2021, for Board review.
4. The Board reviewed a correspondence request from David Boackle to sit for the October 2021 PE exam for Fire Protection Engineering. On a motion from Board member Dennis Truax and second by Board member Joe Lauderdale, it was recommended that Mr. Boackle be cited for the October 2021 exam. The motion carried unanimously.
5. On a motion by Board member Joe Lauderdale with a second by Board member Carey Hardin, the Board voted to establish a policy by which a

Board member who is rolling off the board and is in good standing can be given emeritus status, upon written request and without a vote by the Board. The exception being that the Board would vote on any member to whom they do not wish to have emeritus status. Motion carried unanimously. Policy statement to be submitted by the Board Attorney at the next board meeting.

## **B. Disciplinary/Legal Matters**

The Board reviewed and discussed the status of cases in progress. Board Attorney Turner with Ms. Phillips, Mr. Humphreys and the assigned Board Member(s) updated the Board on open disciplinary and /or legal matters. Board member Mike Thornton with a second by Board member Joe Lauderdale made a motion for the board to consider going into executive session to discuss disciplinary matters. Motion carried unanimously.

On a motion by Board member Carey Hardin and a second by Board member Mike Thornton, the Board voted to go into executive session to discuss disciplinary cases. Motion carried unanimously.

The following matters were voted on in executive session:

- Scheduled the conclusion of the licensure hearing in Case No. 0820/03
- Prepare a Complaint in Case No. 0121/12 with an Agreed Order and fine of \$5,000.
- Dismissal of Case No. 0720/02
- Provide a letter of education and require attendance at a Standards class for both Case No. 0321/16 and 0621/22. Open a formal complaint for Case No. 0621/22 with a fine of \$250.
- The Board voted to not act upon a complaint reporting a potential code of professional conduct violation arising from a billboard, which stated in part “providing engineering excellence” for Case No. 0521/18.

At the conclusion of all reports, Board member Patrick Martino with a second by Board member Joe Lauderdale made a motion to accept the reports presented including the recommendation. Motion carried unanimously.
