### MINUTES October 6, 2021 Jackson, Mississippi

### I ROLL CALL AND APPROVAL OF MINUTES

### 1. Roll Call

## 2. Review and Approval of Minutes

The Board reviewed the minutes of the August 4, 2021, meeting. On a motion from Board Member Mike Thornton and second by Board Member Joe Lauderdale, the minutes were approved as submitted. The motion carried unanimously.

## **II BUSINESS**

## A. Executive Director's Report

- 1. The Executive Director presented information relative to the review and update of the forms, applications, and associated instructions for the agency specifically the draft complaint form presented for board review.
- 2. The Executive Director presented information on the License renewal process just five days into the 2021 season. The preferred browser for using the online licensure / renewal system is Firefox followed by Google Chrome.
- **3.** The Executive Director presented information relative to two communication inquiries received since the August 2021 board meeting regarding:
  - (1) A Compliance inquiry
    - a. On a motion by Board Member Bill Mitchell and second by Board Member Steve Twedt, the Board authorizes the Board Attorney to develop a response letter to the compliance inquiry on Rule 13.3. The letter once drafted should be submitted to Steve Twedt for review. Once approved the letter should be submitted to the inquiring entity.
  - (2) A Licensure requirement inquiry re: constructed enclosures
    - a. On a motion by Board Member Carey Hardin and second by Board Member Dennis Truax, the Board requests the Executive Director and / or Board Attorney to develop a response indicating that if the enclosures are mass produced then licensure is not required. However, if the enclosures are custom built per order, then it is the opinion of the Mississippi Board that licensure is required for both the design engineer and firm.

Both motions carried unanimously.

4. The Executive Director presented the financial report dated July 23, 2021 (EOY 2021), July 31, 2021 (FY 2022), and August 31, 2021 (FY 2022) for Board review.
