On a motion from Board Member Bill Mitchell and second by Sarah Tracy, the August 2, 2023, meeting agenda was submitted for approval with additions to Item V.3 of the agenda. The motion carried unanimously.

2. Review and Approval of Minutes

Joe Lauderdale, PE

The Board reviewed the minutes of the June 21, 2023, regular meeting. On a motion from Board Member Steve Twedt and second by Board Member Sarah Tracy, the minutes for the June 21, 2023, meeting was approved as submitted. The motion carried unanimously.

II BUSINESS

A. Executive Director's Report

- 1. The Executive Director presented information relative to the review and update of the forms, applications, and associated instructions for the agency, including complaints, decoupling, and initial licensure forms.
- **2.** The Executive Director Humphreys presented information on:

Truax, the Board voted to approve changes to Chapter 15 of the Board Rules and Regulations, as suggested by legal. Additionally, after Board Member Twedt and Executive Director Humphreys' presentation, the Board voted to approve the addition of a licensure fee to rule 5.2 and revised the fee schedule accordingly. Motion carried unanimously.
 - (c) On a motion from Board Member Dr. Dennis D. Truax and a second by Board Member Blake Collins, the Board voted to establish a committee to address unlicensed practice complaints and /or investigations. The committee will be chaired by Board Member Bill Mitchell and include Board members Blake Collins and Dr. Dennis D. Truax. Motion carried unanimously.
 - (d) On a motion by Board member Bill Mitchell and a second by Board member Blake Collins the Board voted to approve a one-time shredding contract for the purpose of completing on-site shredding.
 - (e) The financial reports dated May 31, 2023, and June 30, 2023, for Board review.

B. Disciplinary/Legal Matters

The Board reviewed and discussed the status of cases in progress. Attorney Kiana Foster with Mr. Humphreys and the assigned Board Member(s) updated the Board on open disciplinary and /or legal matters.

On a motion by Board Member Sarah Tracy and a second by Board Member Blake Collins, the board voted to close the regular session for the purpose of discussing legal matters. Motion carried unanimously.

On a motion by Board Member Bill Mitchell and a second by Board Member Joe E. Lauderdale, the Board voted to go into executive session to discuss disciplinary cases. Motion carried unanimously.

On a motion by Board Member Clint Tidwell and a second by Board Member Carey Hardin, the Board voted to exit closed session. Motion carried unanimously.

Regarding the inquiry received about a surveying licensee that has a terminal illness, absent an actual filed complaint form, the Board instructed the Investigator to take no further action.

Regarding the inquiry concerning a comment made on someone's Facebook page which the inquirer interpreted as "unlicensed practice" was occurring, but wouldn't file a complaint, the Board directed that without a properly filed complaint or presented prima facia evidence as required by the rules, that the Investigator was to take no further action; and a Board Member would contact the inquiring licensee concerning the Rules that govern complaints.

Concerning the renewals of Mitchell David Simpson and his firm Entech, the Board ratified the recommendations and actions of the Disciplinary Review Committee and suspended both licenses pending revocation. The Investigator was directed to notify them of the suspension and of the right to request reconsideration.

At the conclusion of all reports, Board Member Joe E. Lauderdale with a second by Board Member Blake Collins made a motion to accept the report and recommendations, as presented. Motion carried unanimously.
