## A. Executive Director's Report

- 1. The Executive Director presented information relative to the review and update of the forms, applications, and associated instructions for the agency, including complaints, decoupling, and initial licensure forms.
- **2.** The Executive Director presented information on:
  - (a) The financial reports dated March 31, 2023, and April 30, 2023, for Board review.
  - (b) The proposed fee schedule for fiscal year 2023 2024, for Board review
- 3. The Executive Director presented information on the current records retention requirements for the State relative to the current agency records prior to the move to the new office space. The Board voted on recommendation by Board Member Dr. Dennis Truax and Board Member Clint Tidwell to nominate Board Members Sarah Tracy and Blake Collins along with agency staff Monica Gilmore and Board Attorney Kim Turner to serve on the Records Retention committee. Motion carried unanimously.

### **B.** Personnel Matters

Mr. Humphreys will continue to be employed at the will and pleasure of the board and comp time accrued, if any, will be restricted to 40 hours/month. This change in status became effective as of June 1, 2023. Mr. Humphreys will also serve as Interim Executive Director until such time as the Executive Director vacancy is filled.
- The Board voted to initiate the process of solicitation for the position of Executive Director of the agency to include:
  - o Development and approval of the language for the position
  - o Advertise for the Executive Director position
- The Board voted to implement a 10% pay raise for agency staff Monica Gilmore and Pamela Shields, effective June 1, 2023.
