# **Executive Summary**

This section provides a comprehensive overview of how each U.S. state and territory manages Continuing Education (CE) requirements for professional engineers and land surveyors, with a focus on reciprocity and compliance for out-of-state licensees. The findings are categorized into four distinct policy approaches: states that (1) adhere exclusively to a home state rule, (2) accept CE from other jurisdictions if it meets their standards, (3) require licensees to meet in-state CE requirements regardless of home state compliance, and (4) have no CE requirement.

The goal of this analysis is to support consistent and informed decision-making by identifying national trends in CE policy and highlighting states with flexibility toward license mobility. This information may guide Mississippi's ongoing efforts to align its practices with regional standards, reduce barriers for multi-state licensees, and ensure continued professional competency.

The CE policies for all 50 states, the District of Columbia, and the four U.S. territories (Guam, Puerto Rico, U.S. Virgin Islands, and the Northern Mariana Islands) have been evaluated. For each jurisdiction, the report presents the CE reciprocity category, a concise policy description, and additional notes where clarification or procedural exceptions apply.

# **Category Definitions**

- 1. <u>Exclusively Home State Rule:</u> Licensees only need to comply with CE requirements of their home state.
- 2. <u>Accepts Out-of-State CE:</u> CE completed in another state is accepted if it meets the receiving state's requirements.
- 3. <u>Must Meet In-State CE:</u> Licensees must comply with the state's specific CE rules regardless of out-of-state compliance.
- 4. **No CE Requirements:** The state or territory does not require CE for licensure renewal.





# **Executive Summary**

This section provides a detailed analysis of how all U.S. states and territories evaluate engineering and surveying experience for comity (endorsement) licensure, with a focus on the use of the NCEES Record. While many jurisdictions fully accept a transmitted NCEES Record as sufficient for experience verification, requiring only the standard application—others impose additional requirements such as ethics exams, background checks, or PE-only references. A smaller number of states require applicants to complete a state-specific experience verification form, even when an NCEES Record is submitted. By categorizing each jurisdiction based on its level of acceptance, this analysis clarifies expectations for multi-jurisdictional licensure and highlights areas where administrative burdens may increase. All 50 states, the District of Columbia, and the four U.S. territories (Guam, Puerto Rico, U.S. Virgin Islands, and the Northern Mariana Islands) have been evaluated, with each entry including the verification method, key details, and any notable exceptions.

# **Category Definitions**

- 1. <u>Accepts NCEES Record:</u> no additional forms or documentation required besides the standard application and fees.
- 2. <u>Requires Additional Information:</u> the NCEES record is accepted, but the jurisdiction still requires supplementary documentation or application pieces (e.g. state application, CHRC, discipline-specific verification).
- 3. **Requires State-Specific Verification Form:** the NCEES Record is not accepted in lieu of a state experience form and must be supplemented or replaced by the jurisdiction's own form.

# **State and Territory Experience Verification Method Categories Alabama (AL)**

Category: Accepts NCEES Record

Details: Applicants must complete Alabama's online application, including citizenship declaration and education details.

#### Notes:

- If the NCEES experience was verified by someone not licensed as a PE, the Alabama State-Specific Experience Verification Form must also be submitted.

# Colorado (CO)





# **Executive Summary**

This report provides a national overview of how U.S. states and territories handle age-based exemptions from continuing education (PDH/CPC) requirements for professional engineers and land surveyors. The analysis categorizes each jurisdiction as either (1) granting a formal exemption, (2) not offering an exemption, or (3) lacking sufficient public information.

Of the 55 jurisdictions evaluated, only five—Arkansas, Georgia, Kentucky, South Carolina, and Alaska—offer age- or tenure-based exemptions. These policies typically apply to licensees aged 60 or older with 20 to 30 years of continuous licensure. In contrast, 49 jurisdictions, including Mississippi, do not exempt older licensees and maintain uniform CE requirements regardless of age. One jurisdiction, the U.S. Virgin Islands, had no clear policy available at the time of review.

This summary supports Mississippi's ongoing policy review by identifying national practices. While most states maintain consistent CE standards across age groups, a small minority recognizes exemptions for long-serving professionals. This information may inform future decisions regarding CE requirements for senior licensees.




